EARNESTLY REQUESTING THE HONORABLE PROCESO J. ALCALA, SECRETARY, DEPARTMENT OF AGRICULTURE (DA) TO GRANT THE AMOUNT OF TEN MILLION PESOS (PHP10M) TO BE USED FOR THE CONSTRUCTION/REHABILITATION OF BARANGAY BAGONG SIKAT TO SITIO MARARIM TO SITIO LAMBOK, BARANGAY MAUJAO FIVE KILOMETER (5km) FARM TO MARKET ROADS

“WHEREAS, Section 1, Article XII of the Constitution provides that the goals of the national economy are more equitable distribution of opportunities, income and wealth, a sustainable increase in the amount of goods and services produced by the Nation for the benefit of the people and an expanding productivity as the key to raising the quality of life for all, especially the underprivileged;
