RESOLUTION REQUESTING ATTY. EDGARDO C. ACERON, MUNICIPAL LEGAL CONSULTANT, MUNICIPALITY OF BULALACAO, ORIENTAL MINDORO TO FILE A MOTION TO INTERVENE BEFORE THE SUPREME COURT OF THE PHILIPPINES, MANILA, SEEKING NULLIFICATION OF THE DECISION OF THE REGIONAL TRIAL COURT, PUERTO PRINCESA CITY, PALAWAN ENTITLING THE PROVINCE OF PALAWAN FOR A 40% SHARE IN THE UTILIZATION AND DEVELOPMENT OF THE \$4.5 BILLION CAMAGO-MALAMPAYA NATURAL GAS PROJECT

“WHEREAS, the Regional Trial Court of Puerto Princesa City, Palawan has rendered a decision entitling the Province of Palawan for a 40% share in the utilization and development of the \$4.5 Billion Camago-Malampaya Natural Gas Project;

“WHEREAS, the longest pipeline in the entire province of Oriental Mindoro was installed on areas within the territorial jurisdiction of the Municipality of Bulalacao as part of the Camago-Malampaya Natural Gas Project;

“ WHEREAS, it is inconceivable if not outright disagreeable that the indemnity be solely enjoyed by Palawan whereby said Project had a sprinkling of adverse effects in the environment and economy of several local government units where it traversed its way to the refinery at Batangas;

“WHEREAS, it is just and proper that the Municipality of Bulalacao, Province of Oriental Mindoro be compensated for the damages incurred and the dislocation of many fisherfolks from their only means of livelihood and for other ill-effects brought about by the flowlines laid down beneath the sea-bed of the coast of Bulalacao; by the Company implementing the Camago-Malampaya Natural Gas Project; Now, therefore, be it


