REQUESTING THE DEPARTMENT OF BUDGET AND MANAGEMENT (DBM) TO TRANSFER THE INTERNAL REVENUE ALLOTMENT (IRA) OF THE LOCAL GOVERNMENT UNIT OF BULALACAO, ORIENTAL MINDORO FROM LAND BANK OF THE PHILIPPINES (LBP), PINAMALAYAN BRANCH TO LAND BANK OF THE PHILIPPINES, ROXAS BRANCH, ROXAS, ORIENTAL MINDORO

"WHEREAS, under Section 18 of Republic Act No. 7160 entitled the Local Government Unit to a just share of national taxes which shall be automatically and directly released to them without any further action as provided for under Section 286 of the same law in which releases of shares of Local Government Units of Internal Revenue Taxes where required to be done automatically within the first five (5) days of every quarter are not subject to lien and may not be withheld for any reason, and such was further emboldened by the provision under Section 293 requiring the remittance of the share of Local Government Unit;


"WHEREAS, Section 311 of R.A. 7160 also provided that local treasurer shall maintain depository in the name of their respective Local Government Unit with banks preferably government own located in or nearest to their respective areas of jurisdiction earning of its depository accounts shall appear exclusively their too;


