“WHEREAS, these two families shared plenty of experiences when some of their members used to live in Bulalacao with their brother, Liga President Virgelio M. Astillo;


“WHEREAS, such an encounter with the two generous families left an indelible mark to the hearts of the visitors from this Municipality for that precious time shared; Now, therefore, be it


