**ENDORING TO THE LAND TRANSPORTATION FRANCHISING AND REGULATORY BOARD (LTFRB) THE APPLICATION OF DELA ROSA BUS CORPORATION TO HAVE A LINE FRANCHISE FROM THE MUNICIPALITY OF BULALACAO, PROVINCE OF ORIENTAL MINDORO TO CUBAO, QUEZON CITY**

**"WHEREAS,** the rapid rate of population grow and demand for modernization in the province have given rise to a rapid movement of both people and goods;
