EARNESTLY REQUESTING HER EXCELLENCY GLORIA MACAPAGAL ARROYO, PRESIDENT, REPUBLIC OF THE PHILIPPINES TO ALLOCATE THE AMOUNT OF FIVE MILLION PESOS (PHP5M) TO BE USED FOR THE INSTALLATION OF STREETLIGHTS IN THE MUNICIPALITY OF BULALACAO, PROVINCE OF ORIENTAL MINDORO

“WHEREAS, the Municipality of Bulalacao is situated in the southernmost tip of the Province of Oriental Mindoro which was declared as Pro-Poor Municipality pursuant to Executive Order No. 370;

“WHEREAS, Bulalacao faces an isolation among the rest of the towns due to the absence of a good transportation system and lack of sufficient rural electrification which add to the social and economic inferiority of this Fourth Class Municipality;

“WHEREAS, hounded with financial constraints, various developmental projects and programs could not be readily implemented such as that of the installation of streetlights which shall not only provide convenience among the motorists and pedestrians alike but likewise ensure their safety particularly during nighttime;

“WHEREAS, it is highly hoped that Her Excellency, President Gloria Macapagal Arroyo shall give priority to this noble request for the benefits of our town and its people, Now, therefore, be it;

RESOLVED AS IT IS HEREBY RESOLVED, To: Earnestly request Her Excellency Gloria Macapagal Arroyo, President, Republic of the Philippines to allocate the amount of Five Million Pesos (Php5M) to be used for the installation of streetlights in the Municipality of Bulalacao, Province of Oriental Mindoro,




