EARNESTLY REQUESTING THE DEPARTMENT OF PUBLIC WORKS AND HIGHWAYS (DPWH) THRU THE SOUTHERN MINDORO DISTRICT ENGINEERING OFFICE, REGIONAL OFFICE IV-B, ROXAS, ORIENTAL MINDORO TO KINDLY REGULARLY FURNISH THE SANGGUNIANG BAYAN OF BULALACAO, ORIENTAL MINDORO WITH LIST OF NATIONAL GOVERNMENT'S IMPLEMENTED, ON-GOING AND TO BE IMPLEMENTED PROJECTS IN THIS MUNICIPALITY

"WHEREAS, the establishment of DPWH District Office in Roxas, Oriental Mindoro several years ago was made possible through insistent public demands from the Second Congressional District of the Province believing that implementation of infrastructures particularly roads and bridges be immediately done and repair and maintenance of these public works projects be responded in a short notice and it is true because comfort and convenience in transportation has been already felt by both the vehicles and the transporting public;

"WHEREAS, the DPWH has the complete lists of projects funded by the national government that the Sangguniang Bayan of Bulalacao, Oriental Mindoro desires to be furnished to serve as reference in the enactment of supplemental legislative actions to fastract, support and monitor the implementation of these projects that shall redound to improved social and economic condition of its constituents;

"WHEREAS, the DPWH regularly furnishes the Office of the Municipal Mayor with copies of such lists but not the Sangguniang Bayan of Bulalacao which is the approving body of investment programs and appropriation ordinances;


"WHEREAS, these lists of national government projects shall also be helpful in the formulation and approval of developmental programs and projects to be included in the Annual Investment Program of the Municipality and approval of the Municipal Annual Budget; **Now, therefore, be it**






