### **RESOLUTION NO. 21-12-417**

**RESOLUTION DECLARING THE APPROPRIATION ORDINANCE NO. 2-2021, SUPPLEMENTAL BUDGET NO. 2 FY 2021 OF BARANGAY NASUCOB, BULALACAO, ORIENTAL MINDORO ENTITLED "APPROPRIATING THE AMOUNT OF EIGHT HUNDRED ELEVEN THOUSAND THREE HUNDRED SIXTY EIGHT PESOS AND SEVENTY NINE CENTAVOS (PHP811,368.79) TAKEN FROM SURPLUS 2020" OPERATIVE IN ITS ENTIRETY**

**"WHEREAS**, Section 57 and Section 447 par (li) of RA No. 7160 empower the Sangguniang Bayan to review all ordinances passed by the Sangguniang Barangay to determine whether these are within the scope of the prescribed powers of the sanggunian and not to be inconsistent with law or municipal ordinance;

**"WHEREAS**, the Sangguniang Barangay of Nasucob, Bulalacao, Oriental Mindoro submitted its Supplemental Budget No. 2 FY 2021 showing therein the sources of income and object of expenditures to this Sanggunian for review on December 20, 2021 pursuant to the provisions of Republic Act (R.A.) No. 7160;

**"WHEREAS**, the Supplemental Budget No. 2 FY 2021 of Barangay Nasucob was duly taken up by the Sangguniang Bayan of Bulalacao, Oriental Mindoro in the regular session held on December 27, 2021 and was found to be consistent with pertinent laws, rules and regulations;

**"WHEREAS**, Sangguniang Barangay of Nasucob, Bulalacao, Oriental Mindoro is likewise advised to strictly follow the recommendations of the Local Finance Committee as reflected in the attached review letter which became integral part of this resolution;

"WHEREAS, it is therefore understood that disbursement of appropriation shall be guided by existing rules and regulations of Commission on Audit and all other government agencies, Now, therefore, be it
