**EARNESTLY REQUESTING THE GMA KAPUSO FOUNDATION TO ALLOCATE THE NECESSARY FUNDS UNDER ITS KAPUSO TULAY PARA SA KAUNLARAN PROJECT FOR THE CONSTRUCTION OF FOOTBRIDGE IN SITIO TABUK, BARANGAY POBLACION, BULALACAO, ORIENTAL MINDORO**

**“WHEREAS,** Sitio Tabuk, Barangay Poblacion is a fishing village composed of approximately two thousand residents whose main source of income is fishing;

**“WHEREAS,** during the occurrence of typhoon with heavy rains, Sitio Tabuk always take a pre-emptive evacuation located in Barangay Poblacion where they need to cross the hanging bridge temporarily built of wood and cyclone wire wherein during emergencies volume of people rushing to go to the mainland is out of control;

**“WHEREAS,** the hanging bridge built several years ago which approximately fifty (50) meters in length was damaged by Typhoon Quinta last October 26, 2020 that crossing on it poses danger and might lead to the loss of precious human lives;

**“WHEREAS,** being the Pro-Poor Municipality with limited funds, our only hope in the benevolence of a private institution like the GMA Kapuso Foundation to give priority and necessary funds to the plight of the marginal fisherfolks in Sitio Tabuk that a footbridge made of concrete and steel be provided to them for their safety and easier access to schools and markets; **Now, therefore, be it**

**RESOLVED AS IT IS HEREBY RESOLVED, To:** Earnestly request the GMA Kapuso Foundation to allocate the necessary funds under its Kapuso Tulay Para sa Kaunlaran Project for the construction of footbridge in Sitio Tabuk, Barangay Poblacion, Bulalacao, Oriental Mindoro;
