“WHEREAS, pursuant to Sections 107 to 109 of the Local Government Code, the Municipal Development Council (MDC) composed of representatives of non-governmental organizations, all punong barangays, concerned municipal officials and the representative of the congressman convened on October 1, 2020 in order to formulate the annual investment program in order to achieve the LGU of Bulalacao’s mission “to establish an efficient local organization responsive to the needs of the locality and effectively manages its resources to sustain growth and development and the vision “Beautiful and Bountiful Bulalacao”;

“WHEREAS, the MDC came-up with the 2021 Annual Investment Program (AIP) which is in consonance with the provincial, regional and national development thrusts, after undergoing a careful process consisting of review and assessment of the status of projects implemented in the preceeding year, consultations and workshops with various sectors and barangay officials, cross-sectoral integration activities and strategic planning workshop in order to address the priority needs in social services, economic development and environmental development sectors;

“WHEREAS, the AIP is a basic document linking the local development plan to the budget of the Municipality for the current year and contains a prioritized list of programs, projects and activities (PPAs) which are derived from the Comprehensive Development Plan matched with financing resources to be implemented within a year;

"WHEREAS, programs and projects listed under the fiscal year 2021, 20% Development Fund with a total amount of Php36,119,520.60 are found eligible for funding pursuant to policies and guidelines mentioned in the Joint Memorandum Circular No. 2011-1 of the Department of Budget and Management and the Department of the Interior and Local Government dated April 13, 2011;
