REQUESTING ENGR. CAESAR F. QUEBEC, CENRO, COMMUNITY ENVIRONMENT AND NATURAL RESOURCES OFFICE, SAN MARIANO, ROXAS, ORIENTAL MINDORO TO FACILITATE THE CONVERSION OF A CERTAIN TIMBERLAND AREAS IN BULALACAO PARTICULARLY IN BARANGAY SAN JUAN INTO ALIENABLE AND DISPOSABLE LANDS

WHEREAS, timberland land means land other than land owned by the federal government and land designated by the board as experimental forest land which is available for, and capable of growing a crop of trees of a commercial species used to produce lumber and other forest products;

WHEREAS, an alienable and disposable land are lands of public domain that has been classified and declared as such and is available for disposition;

WHEREAS, Bulalacao is a home to hanunuo mangyans who composed of approximately twenty four percent of the total population living in the timberland and because of poverty suffer the difficulties for daily survival;

WHEREAS, some parts of the timberland areas in Bulalacao are being used as residential areas for so many years that residents thereat are hoping that it will be converted into alienable and disposable lands to provide them the privilege to develop the lands they occupied and somehow facilitate the titling of the lot for this favor;


