RESOLUTION EXPRESSING/SIGNIFYING STRONG OBJECTION OF THE LOCAL GOVERNMENT UNIT OF BULALACAO, ORIENTAL MINDORO TO THE APPROVAL OF ANY LEASE AGREEMENT APPLICATION OF ALL FORESHORE, MARINE AND SALVAGE AREAS WITHIN OUR TERRITORIAL JURISDICTION TO ANY INDIVIDUAL, ENTITY, COMPANY OR CORPORATION OR BY ANY GOVERNMENT AGENCY WITHOUT PROPER CONSULTATION AND APPROVAL OF THE LGU BULALACAO

"WHEREAS, the Municipality of Bulalacao is composed of eight (8) coastal barangays added to several islands and islets boost with tourism potentials and with such fishing ground where fishing becomes the major source of income of the residents;

"WHEREAS, Bulalacao is emerging into an Agro-Tourism Municipality that concerted efforts both from the government and private sectors is needed to conserve and protect its marine resources not only for the present use and survival but most of all for the social and economic benefits of the future generation;

"WHEREAS, foreshore and salvage areas within the territorial jurisdiction of Bulalacao should not be opened for lease or sale to any private or public individual or entities because these areas should be preserved for future improvements that shall be used publicly and benefit more of the marginalized group;

"WHEREAS, the Local Government Unit of Bulalacao should have the full control and use of its foreshore and salvage zones for its current and future projects and programs beneficial to its people than to lease it to private individuals/corporation; Now, therefore, be it
