"WHEREAS, on May 2012 to December 2013, the Department of Environment and Natural Resources conducted survey of the Bulalacao Cadastre (CAD 1298-D) pursuant to Executive Order 192 dated July 10, 1987 and DENR Administrative Order No. 2007-29;

"WHEREAS, the Municipal Boundary Index Map (MBIM) of Bulalacao Cadastre (CAD 1298-D) situated in the Municipality of Bulalacao, Province of Oriental Mindoro contained an area of 35,926.1137 hectares;

"WHEREAS, the political boundary survey was approved from the actual claims and informed to approve cadastral survey of adjoining municipalities including the boundaries of the Municipalities of Bulalacao and Mansalay, Oriental Mindoro subject for amendment for any possible boundary conflict to be resolved by the concerned municipalities on the resolution of boundary conflict in accordance with existing laws, rules and regulations; Now, therefore, be it






