**WHEREAS**, a regional hospital or district hospital is a hospital that serves a geographic region larger area than a single local or rural area. Its primary role is to increase the quality of medical and health care and in specialized services to the rural population;

**WHEREAS**, the Municipality of Bulalacao, Province of Oriental Mindoro is strategically located in the center of MIMAROPA region accessible both by land and sea. It's port has a daily regular route to Caticlan, Aklan and more routes are expected to operate going to Romblon, Marinduque, Palawan and to Occidental Mindoro which is almost 50 kms. away and its travel time by land is only one (1) hour;

**WHEREAS,** Oriental and Occidental Mindoro is a home to hanunuo mangyans who live in the hinterland who because of poverty could hardly meet their daily basic needs such as food, clothing and shelter and whose medical needs and services are deprived or less priority because daily survival comes first;

**WHEREAS,** at the moment, the nearest regional hospital is located in Batangas City that patients coming from MIMAROPA region need to travel hundred of miles away by land and by sea where patients of emergency cases and their families bring a lesser hope of survival;


**WHEREAS,** it is great to note that the Department of Health several years ago appropriated the amount of Php85M to be used for the construction of the hospital in Bulalacao that today it is somehow ready for operation which this Sanggunian suggests that the same be established and declared into a regional hospital to better serve the whole MIMAROPA region; **Now, therefore, be it**

**RESOLVED AS IT IS HEREBY RESOLVED, To:** Earnestly request Congressman Alfonso V. Umali, Jr., 2<sup>nd</sup> District Representative, Province of Oriental Mindoro to facilitate and support the establishment of a Regional MIMAROPA Hospital in the Municipality of Bulalacao, Province of Oriental Mindoro;
