ACOSTA AS MUNICIPAL GOVERNMENT DEPARTMENT HEAD I UNDER
PERMANENT STATUS IN THE LOCAL GOVERNMENT UNIT OF
BULALACAO, ORIENTAL MINDORO**

WHEREAS, the Local Government Unit of Bulalacao, Oriental Mindoro through the Sangguniang Bayan enacted Municipal Ordinance No. 21-10-302 entitled "Ordinance creating the Municipal Disaster Risk Reduction and Management Office of the Local Government Unit of Bulalacao, Oriental Mindoro, defining the qualifications, powers and duties of the Municipal Government Department Head II, and appropriating funds therefor" which was amended through Municipal Ordinance No. 22-03-314 by changing the Municipal Government Department Head II into Municipal Government Department Head I'

WHEREAS, Mr. German S. Acosta started his career in public service in 1989 as Real Property Appraiser I, as Private Secretary in 1990 in the Local Government Unit of Bulalacao. In 1997, he was elected as Punong Barangay of Poblacion where he served for ten years, he also became the President of the Association of Barangay Captains where he sit as ex-officio member of the Sangguniang Bayan until 2012. In 2013, Mr. German S. Acosta was elected as a regular member of the Sanggunian where he served for three consecutive terms or a total of nine years;

WHEREAS, the appointee met all the minimum requirements set by the Civil Service Commission and he passed the screening and selection processes conducted by the Personnel Selection Board and was finally appointed by the Local Chief Executive under permanent status on July 1, 2022;

WHEREAS, his appointment was submitted to this Sanggunian for concurrence pursuant to Section 443 of the Local Government Code of 1991 which provides that appointment made by the Local Chief Executive needs concurrence of the majority of all the Sangguniang Bayan Members; **Now, therefore, be it**


