"WHEREAS, the Municipality of Bulalacao, Province of Oriental Mindoro is a Pro-Poor Municipality pursuant to Proclamation No. 1801 and is located in the southernmost tip of the province and whose population is composed of approximately 20% hanunuo mangyans;

"WHEREAS, the newly constructed PNP Bulalacao Station still lacks various logistical support and facilities particularly that of a patrol car necessary in the effective implementation of laws and ordinances, surveillance and monitoring services in an effort of the police officers to maintain peace and order in the locality;


"WHEREAS, faced with financial constraints, the Municipality of Bulalacao could not readily provide the PNP with a patrol car that this is believed to be realized thru the assistance of the Philippine National Police thru the able leadership of Chief Ronald de la Rosa; Now, therefore, be it
