**RESOLUTION REQUESTING THE DEPARTMENT OF HEALTH TO PROVIDE EQUIPMENT, MATERIALS, SUPPLIES AND BLOOD BAGS NEEDED FOR BLOOD EXTRACTION SERVICES FOR BLOOD TRANSFUSION PURPOSES AT BULALACAO COMMUNITY HOSPITAL IN THE MUNICIPALITY OF BULALACAO, PROVINCE OF ORIENTAL MINDORO**

**“WHEREAS**, pursuant to Republic Act No. 7719, also known as the National Blood Services Act of 1994, promotes voluntary blood donation and to regulate blood banks, it aims to inculcate public awareness that blood donation is a humanitarian act;

**“WHEREAS**, Bulalacao is a 3<sup>rd</sup> class municipality hounded with financial constraints located at the southernmost tip of the Province of Oriental Mindoro, has a population of 44,366 based on 2020 census, 25 percent of which are indigenous people called Hanunuo Mangyan, has a municipal government that uplift the general health condition of the people;

**“WHEREAS**, the Bulalacao Community Hospital is the only hospital in the said municipality that can cater immediate medical needs and emergencies to its people, however, it is still has no proper blood extraction services with complete equipment and facility that can be used for blood transfusion needs of its patients;

**"WHEREAS**, because of its location, it has been a struggle for its patients and blood donors to obtain blood services, there are instances that some if not most of the blood donors from this municipality after a long travel to Calapan City are being rejected in the screening process of the City's blood center due to certain reasons;

**"WHEREAS**, the Local Government of Bulalacao is hopeful to have blood extraction services in its community hospital with the aim that it would lessen the hassle of screening, collecting and supplying the most needed bloods for ailing patients of the municipality; Now, therefore, be it...


