RESOLUTION NO. 20-09-400

RESOLUTION REQUESTING PRESIDENT RODRIGO ROA DUTERTE, PRESIDENT, REPUBLIC OF THE PHILIPPINES TO GIVE INSTRUCTION TO PHILHEALTH TO CONDUCT STUDY, EVALUATION AND REVIEW OF THE POLICIES ON BENEFIT CLAIM PACKAGE SUBMITTED BY MEMBERS OF PHILHEALTH PARTICULARLY THOSE UNDER FORMAL GROUP PAYING A REGULAR MONTHLY PREMIUM

"WHEREAS, pursuant to the 1987 Constitution, the State shall adopt an integrated and comprehensive approach to health development which shall endeavor to make essential goods, health and other social services available to all the people at affordable cost. There shall be priority for the needs of the underprivileged, sick, elderly, disabled, women and children. The state shall endeavor to provide free medical care to paupers;

"WHEREAS, the Philippine Health Insurance Corporation (PhilHealth) is a tax-exempt, government-owned and controlled corporation (GOCC) of the Philippines, its stated goal is to "ensure a sustainable national health insurance program for all";

"WHEREAS, January of this year, the monthly PhilHealth contribution rate for employed members increased from 2.75 % to 3 % of their monthly basic salary as part of the full implementation of the Universal Health Care (UHC) Law;

"WHEREAS, members who are persons with disability (PWD), unemployed senior citizens, lifetime members, and sponsored and indigent members are exempted in paying the PhilHealth contribution;

"WHEREAS, direct contributors who are under the formal group paying regular monthly premium wish to be clarified how the benefit claim package is computed. May we cite the case of one of the local government employee who was confined for one (1) week and who was hospitalized for the first time with a hospital bill of PhP70,000. He felt relaxed because of being a pPhilHealth member of assured medical package, but to his dismay only PhP6,000 was paid by PhilHealth so that this resolution is send to seek further information and clarifications of those members under the formal group;

NOW, THEREFORE, BE IT, RESOLVED AS IT IS HEREBY RESOLVED, To: request President Rodrigo Roa Duterte, President, Republic of the Philippines to give instruction to PhilHealth to conduct study, evaluation and review of the policies on health benefit claim package submitted by members of PhilHealth particularly those under formal group paying a regular monthly premium.






