VITUG, REGION IV-B AND GRANT OF STUDENT PERMIT AND PROFESSIONAL DRIVER'S LICENSE TOGETHER WITH ALL TESTS AND EXAMINATIONS RELATIVE HERewith SHALL BE MADE AVAILABLE AT LAND TRANSPORTATION OFFICE, PINAMALAYAN EXTENSION OFFICE, PINAMALAYAN, ORIENTAL MINDORO




