RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR TO REPRESENT THE MUNICIPALITY OF BULALACAO, ORIENTAL MINDORO TO ENTER INTO A CONTRACT OF SERVICE WITH EIGHT (8) WELDING INSTRUCTORS AND ADMINISTRATIVE STAFF OF THE BULALACAO TECHNICAL AND VOCATIONAL COLLEGE (BTVC) FOR THE PERIOD STARTING JANUARY 2, 2020 UP TO DECEMBER 31, 2020 IN CONSIDERATION OF THE MONTHLY RATE COMPUTED IN ACCORDANCE TO THEIR COMPETENCE AND ELIGIBILITY AND SUCH OTHER TERMS AND CONDITIONS THAT MAY BE AGREED UPON BY BOTH PARTIES

RESOLVED AS IT IS HEREBY RESOLVED, To: Authorize Mayor Ernilo C. Villas to represent the Municipality of Bulalacao, Province of Oriental Mindoro to enter into a Contract of Service with the following welding instructors and administrative staff of the Bulalacao Technical and Vocational College (BTVC) for the period starting from January 2, 2020 up to December 31, 2020 in consideration of the monthly rate computed in accordance to their competence and eligibility and such other terms and conditions that may be agreed upon by both parties to wit:

RESOLVED FINALLY, That: Any legal encumbrance that may arise in the execution and actual application of this Memorandum of Agreement shall be the sole responsibility of the heads of Implementing Offices or Units;




