EARNESTLY REQUESTING THE OFFICE OF THE CIVIL DEFENSE (OCD) TO ALLOCATE THE NECESSARY FUNDS TO BE USED FOR THE CONSTRUCTION OF PROTECTION DIKE AGAINST STORM SURGE IN BARANGAY MAASIN, BULALACAO, ORIENTAL MINDORO

"WHEREAS, Barangay Maasin, Bulalacao, Oriental Mindoro is an island barangay which does not share a common border with any barangay the nearest of which is Barangay Balatasan which is approximately three (3) kilometers away where the only mode of transportation is by using a motorized banca or simply a banca operated manually;

"WHEREAS, Barangay Maasin is susceptible to storm surge particularly during the onslaught of bad weather condition because it is facing an open sea where sea level rise resulting from extreme meteorological conditions coincidence with high tide and is characterized by pronounced wave swell;

"WHEREAS, in consideration of the above premises, it is important to construct a protection dike along the coastal area to shelter vessels from waves and currents, prevents siltation of a navigation channel, protects a shore area or prevents thermal mixing and most importantly is to protect the coastal residents against storm surge that is likely to occur during the inclement of bad weather condition; **Now, therefore, be it**

RESOLVED AS IT IS HEREBY RESOLVED, To: Earnestly request the Office of the Civil Defense (OCD) to allocate the necessary funds to be used for the construction of protection dike against storm surge in Barangay Maasin, Bulalacao, Oriental Mindoro;
