EARNESTLY REQUESTING THE PROVINCIAL AGRARIAN REFORM OFFICER (PARO), CALAPAN CITY TO SUSPEND THE CANCELLATION PROCEEDINGS OF CERTIFICATE OF LAND OWNERSHIP ORIGINALLY INTENDED TO BE AWARDED TO IDENTIFIED ELIGIBLE BENEFICIARIES OF BARANGAY SAN ROQUE, MUNICIPALITY OF BULALACAO, PROVINCE OF ORIENTAL MINDORO

"WHEREAS, the issue of land ownership in Barangay San Roque, Bulalacao, Oriental Mindoro brought depression, worries and deep emotional turmoil to both the residents and officials for life becomes so uneasy and uncomfortable and fear of losing their homes and investments may come without their knowing;
