RESOLUTION APPROVING APPROPRIATION ORDINANCE NO. 11 OF BARANGAY SAN ISIDRO ENTITLED APPROPRIATING THE AMOUNT OF FORTY THREE THOUSAND EIGHT HUNDRED THIRTY PESOS AND SIXTY SEVEN CENTAVOS (PHP43,830.67) TAKEN FROM HONORARIUM OF BARANGAY OFFICIALS, BARANGAY JUSTICE, CASH GIFT, BARANGAY POLICE AND BARANGAY HEALTH WORKER (BHW) TO AUGMENT FUND FOR MID-YEAR AND YEAR-END BONUS

"WHEREAS, the grant of Mid-Year Bonus equivalent to one (1) month Honorarium as of May 15 shall be given to entitled personnel not earlier than May 15 of the current year pursuant to Budget Circular No. 2017-2 dated May 8, 2017;


"WHEREAS, pursuant to Section 7, Budget Circular No. 2016-4 dated April 28, 2016, elective or appointive barangay officials and employees who have rendered at least a total of or an aggregate of four (4) months of service from January 1 of the current year and who are still in the service as of October 31 of the same year may be entitled to the Year-End Bonus equivalent to one (1) month Honorarium received as of October 31 and Cash Gift of PhP5,000.00; Now, therefore, be it
