**"WHEREAS,** on October 14, 2019, the Sangguniang Bayan of Bulalacao, Oriental Mindoro has approved Resolution No. 19-10-186, series of 2019 authorizing Engr. Ernilo C. - iii. amend/add/delete enrolled deposit account as source/s as source and/or destination account/s access right to the weAccess modules, authorization, rules and/or any information on the original and succeeding enrollments.


