EARNESTLY REQUESTING GOVERNOR ALFONSO V. UMALI, JR., PROVINCIAL GOVERNOR, PROVINCE OF ORIENTAL MINDORO TO ALLOCATE THE NECESSARY FUNDS FOR THE CONSTRUCTION OF A SENIOR CITIZEN BUILDING IN BARANGAY NASUCOB, BULALACAO, ORIENTAL MINDORO

"WHEREAS, the State in recognition of the elderly citizens enacted Republic Act Numbered 9432 entitled "An Act to maximize the Contribution of Senior Citizen to Nation Building, Grant Benefits and Special Privileges and for other purposes" in order to motivate, encourage and maximize senior citizens capability to partake in the task of nation building and to mobilize their families and the communities where they live and to reaffirm the valued Filipino tradition of caring for the old members of the family and the community in general;

"WHEREAS, the enactment of their law is a meaningful State management intervention to operationalize the concepts of productive citizenry, respect and care for the elderly;

"WHEREAS, under the law, cities and municipalities are directed to establish an Office for Senior Citizens Affairs (OSCA) to assist senior citizens in availing themselves of the mutually beneficial privileges solely intended for them;

"WHEREAS, the enshrined functions, responsibilities and privileges outlined for the senior citizens can be given flesh fully if the members actively participate in their meetings, where their ideas are ventilated, weighed and crystallized into a well-planned programs where the center for their exclusive use is an obvious necessity; Now, therefore, be it

RESOLVED AS IT IS HEREBY RESOLVED, To: Earnestly request Governor Alfonso V. Umali, Jr., Provincial Governor, Province of Oriental Mindoro to allocate the necessary funds for the construction of a Senior Citizen Building in Barangay Nasucob, Bulalacao, Oriental Mindoro;






