**"WHEREAS**, the Local Government Unit of Bulalacao, Oriental Mindoro has a realized savings of fifteen million two hundred eighty one thousand seven hundred thirty one pesos and twenty six centavos (PhP15,281,731.26) taken from continuing program and projects for CY 2017, 2018 and 2019, from projects listed in 2019 Supplemental Budget No. 2 which was declared inoperative in its entirety by the Sangguniang Panlalawigan so that it is need to be reprogrammed and from unappropriated funds under General Fund;
