"WHEREAS, a multi-purpose covered court is an infrastructure facility in barangay which serves as an appropriate venue for all barangay programs and activities including the conduct of games such as basketball and volleyball even during heavy rains,

"WHEREAS, the proposed covered court in Barangay Nasucob is adjacent to Nasucob Elementary School so that various school programs and activities may be held for the comfort and convenience of teachers, students and the community;

"WHEREAS, it is believed that with the intervention of the provincial government thru Governor Umali, the construction of a covered court at Barangay Nasucob be given top priority. **Now, therefore, be it**
