**“WHEREAS**, Bulalacao is a third-class Municipality located at the southernmost tip of the Province of Oriental Mindoro, the present thrust of its Local Government for social services is to provide free, accessible and quality education for all;

"WHEREAS, the Bulalacao Technical Vocational College (BTVC) is an institution accredited by TESDA that offers Technical and Vocational Education and Training Programs (TVET) under the Technical Education and Skills Development Authority (TESDA) and the Commission on Higher Education (CHED), it is located at San Roque, Bulalacao, Oriental Mindoro;

"WHEREAS, because of financial constraints, many high school graduates of this municipality were unable to pursue tertiary education, also for students of BTVC, the most common reason why they have to stop their studies is because of the lack of financial assistance, it will give more opportunity for them to have additional scholarship slots that will boost their chances to finish their education, Now, therefore, be it;






