“WHEREAS, Section 16 of Republic Act No. 7160 otherwise known as Local Government cod of 1991 states that every local government unit shall exercise the powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare, within their respective territorial jurisdictions, local government units shall promote health and safety;

“WHEREAS, Bulalacao is a third-class municipality located at the southernmost tip of Oriental Mindoro, has 15 barangays and 8 of which are coastal barangays, and has a municipal government that aims to establish an efficient local organization which is responsive to the needs of the locality and effectively manages its resources to sustain growth and development;

“WHEREAS, because of its location and climate type, Bulalacao is at high risk of weather disturbances and typhoons which causes flooding, storm surges and other damages that affects both agricultural and aquaculture industries, and the safety of the people;

“WHEREAS, hydraulic cutter is used by emergency rescue personnel to assist in the extraction operation from accidents, as well as other rescues in small spaces with the capacity to cut through metal;

“WHEREAS, the provision of hydraulic cutter would not only beneficial to the Municipality of Bulalacao as it is connected to the strong republic nautical highway which has been an entry point to Visayan and Mindanao regions;






