RESOLUTION REQUESTING THE NATIONAL ARCHIVES OF THE PHILIPPINES TO EXTEND TECHNICAL ASSISTANCE TO THE LOCAL GOVERNMENT UNIT OF BULALACAO TO HELP ASCERTAIN THE EXACT DATE OF ESTABLISHMENT OR CREATION OF THE MUNICIPALITY OF BULALACAO, PROVINCE OF ORIENTAL MINDORO BASED ON AVAILABLE RECORDS

“WHEREAS, Section 440 of Republic Act No. 7160 states that the municipality, consisting of a group of barangays, serves primarily as a general purpose government for the coordination and delivery of basic, regular and direct services and effective governance of the inhabitants within its territorial jurisdiction;

“WHEREAS, the glimpse in the history of the Municipality of Bulalacao traced that in 1906 the settlement of its jurisdiction was originally included the now adjacent municipalities of San Jose, Occidental Mindoro (formerly called Mangaring), Mansalay, Roxas (formerly called Paclasan) both in Oriental Mindoro, and the islands of Caluya, Sibay and Semirara all now in the Province of Antique;

“WHEREAS, in 1910 under Act No. 3498, Mangaring, now known as San Jose, Occidental Mindoro was separated from Bulalacao, while the friction between the latter and Mansalay were getting estranged, the was then Congressman Mariano P. Leuterio prompted to work for the creation of Mansalay as a new municipality;


"WHEREAS, ultimately, in 1929 Mansalay was officially separated from Bulalacao, thus, its original territory under Act No. 1820 which included Roxas, Mansalay, San Jose and the islands turned over to Antique was hugely reduced;


"WHEREAS, at this present time, the people of Bulalacao are still uncertain as to which is the exact date of establishment of its actual municipality, it is important to understand the history and its very origin in order to obtain the accurate date of commemoration and further use to its municipal records; Now, therefore, be it...
