**"WHEREAS**, the Sangguniang Bayan Office of the Local Government Unit of Bulalacao, Oriental Mindoro, having its own function and responsibility to provide better legislation and services to the municipality, currently, has 15 Job Order workers that have different valuable roles and duties to assist the Municipal Vice Mayor, Sangguniang Bayan Members, and the Office of the Secretary to the Sanggunian;


**"WHEREAS**, in congruence to DILG Memorandum Circular No. 2023-092, our legislative department, the Sangguniang Bayan of Bulalacao will be joining the DILG 2023 Local Legislative Award, thus, the Sangguniang Bayan Office needs the full workforce of its staff including the Job Order workers to complete all the requirements and files needed to meet the criteria of the said award committee;


**"WHEREAS**, this Sanggunian understands the insufficiency of the local fund, however, due to the abovementioned situations, it is humbly asking the Municipal Mayor to allow four working days a week to all the Job Order workers of the Sangguniang Bayan Office exempting them to the current three-day relyebo system, it also reassures that its wages can be accommodated through the office's Other General Services under the Maintenance and Other Operating Expenditures; Now, therefore, be it...


