AMENDING RESOLUTION NO. 37, ORDINANCE NO. 9, S. 1979 TO TRANSFER THE PARKING SPACE FROM THE MARKET SITE TO THE TOWN PROPER NORTH OF THE INTEGRATED NATIONAL POLICE (INP) BARRACKS AND BESIDE THE BUILDING OF BULALACAO MUNICIPAL HIGH SCHOOL, ORIENTAL MINDORO.

WHEREAS, the National Integrated Police (INP) of Bulalacao Oriental Mindoro, represented by Pat. Soga appeared on the Regular Session held on December 14, 1979;

WHEREAS, Pat. Soga requested this Honorable Body to transfer the parking space from the market site to the town proper, North of the Integrated National Police (INP) beside the building of Bulalacao Municipal High School in order to protect or safeguard passengers coming from San Jose Occidental Mdo, and Calapan, Oriental Mindoro respectively;

NOW, THEREFORE, the Sangguniang Bayan of Bulalacao, hereby ordains that:

SECTION 1. Parking space which is in the public market is now transferred to the town proper North of the Integrated National Police (INP) Barracks and beside the building of Bulalacao Municipal High School (BMHS) Poblacion Bulalacao, Oriental Mindoro.

SECTION 2. All owners and drivers of buses and jeepneys carrying passengers from Calapan and other Municipalities are hereby ordered to park, load and unload cargoes and passengers at the parking space specified in Section 1, hereof while waiting for passengers coming from San Jose and Calapan respectively;

SECTION 3. Parking Fee for buses and jeepneys mentioned in Section 1, hereof shall not exceed the rate enumerated below:

- 1. Buses - - - - - ₱ 2.00 per parking
- 2. Jeepneys - - - - - 1.00 " "

SECTION 4. Collections of the above Fees shall be done by the Municipal Treasurer or his duly authorized representatives;

SECTION 5. Violation of this Ordinance or parts hereof, shall be fined the amount of ₱ 50.00 or more but not exceeding ₱ 200.00 and an imprisonment of 15 days or more but not exceeding 30 days or both such fine and imprisonment at the discretion at the Court.

SECTION 6. Previous Ordinance or Ordinances inconsistent with the provisions of this Ordinance are hereby repealed or modified accordingly.

SECTION 7. This Ordinance shall take effect immediately . . .
