SPECIAL ORDINANCE NO. 05-06-007

TEMPORARILY CLOSING THE MUNICIPAL PARKING AREA IN PUBLIC MARKET, CAMPAASAN, BULALACAO, ORIENTAL MINDORO AND DESIGNATING THE OLD SLAUGHTERHOUSE SITUATED AT THAT BARANGAY AS THE TEMPORARY PARKING AREA

BE IT ORDAINED by the Sangguniang Bayan of Bulalacao, Oriental Mindoro:

SECTION 1. In order to accommodate the selling of goods, merchandise, foodstuffs, commodities or articles of commerce by transient businessmen or traders to the general public during the town fiesta celebration on June 28-29, 2005, the Municipal Parking Area at the Public Market, Campaasan, Bulalacao, Oriental Mindoro is hereby temporarily closed from June 15, 2005 up to June 30, 2005 and designating the old slaughterhouse situated at that barangay as the temporary parking area;

SEC. 2. Any person violating this ordinance shall suffer the penalty of six (6) months imprisonment or shall be fined by an amount of Two Thousand Five Hundred Pesos (Php2,500.00) or both such fine and imprisonment at the discretion of the Court;

SEC. 3. This Special Ordinance shall take effect immediately;






