### SPECIAL ORDINANCE NO. 04-08-07

**AN ORDINANCE AUTHORIZING THE MUNICIPAL MAYOR TO DISTRIBUTE AND DETERMINE THE BENEFICIARIES OF LOT WITH PREFERENTIAL TREATMENT FOR THOSE WHO ARE HOMELESS, INDIGENT AND LANDLESS BONAFIDE RESIDENTS OF BARANGAY CAMBUNANG, BULALACAO, ORIENTAL MINDORO**

**BE IT ORDAINED** by the Sangguniang Bayan of Bulalacao, Oriental Mindoro:

**SECTION 1. STATEMENT OF POLICY.** Cognizant of the welfare of its constituents, the Municipal Government of Bulalacao initiated the granting of lots to those families who were virtually living in abject poverty and who were needing the States' assistance in order to minimize the ill-effects of being under privileged hence, qualified beneficiaries shall be provided with lot not exceeding the maximum area of 150 sq. meters per family;


**SECTION 2.** Such beneficiaries shall be determined and approved by the Local Chief Executive with the recommendation of the Punong Barangay concerned, stating therein that the individual beneficiary is homeless, landless, indigent and is lacking the certain basic social needs to live as a decent human being.


**SECTION 3.** All the beneficiaries shall after three (3) months of occupying the shelter mentioned above thereafter, shall pay the amortization in the amount of Thirty Pesos (Pnp30.00) /each month for the period of Fifteen(15) years.


**SECTION 4.** Failure to comply with the preceeding mode of payment as herein provided for within ten (10) years shall mean forfeiture of rights in favor of the Municipal Government; thereby, by this ordinance granting power to the Municipal Mayor to grant the forfeited lot to other interested and qualified applicants in consultation with the Punong Barangay concerned.


**SECTION 5. EFFECTIVITY.** This special ordinance shall take effect immediately.
