ORDINANCE NO. 05-04-048

ORDINANCE REQUIRING ALL DEPARTMENT OF ENVIRONMENT AND NATURAL RESOURCES (DENR) PERMITTEES FOR TREASURE HUNTING ACTIVITIES TO SECURE A MUNICIPAL PERMIT AS A REQUIREMENT BEFORE THE OPERATION THEREOF AND FOR OTHER PURPOSES

BE IT ORDAINED by the Sangguniang Bayan of Bulalacao, Oriental Mindoro:

SECTION 1. REGULATED ACT. It shall be unlawful for any person, private or juridical to operate, conduct and speculate treasure hunting activities within the Municipality of Bulalacao, Province of Oriental Mindoro without the corresponding permit from the Municipal Mayor including those who are holders of DENR permit;

SECTION 2. IMPOSITION OF FEES. The necessary fees and charges applicable shall be paid to the Municipal Treasurer or his duly authorized representative upon application for permit with the Office of the Municipal Mayor;

SECTION 3. ADMINISTRATIVE PROVISION. Before an application for a permit is acted upon, the Municipal Mayor of his duly authorized representative shall inspect the area applied for and verify the necessary documents to be in conformity with the existing mining laws, rules and regulations. And require presentation of the receipt of payment of the fees and charges impose under the Revenue Code of this Municipality;

SECTION 4. PENALTY. Any violation of the provisions of this Ordinance shall be punished by a fine of not exceeding Five Thousand Pesos (Php5,000.00) or Imprisonment of not exceeding six (6) months or both, at the discretion of the Court;


SECTION 6. EFFECTIVITY. This ordinance shall take effect ten (10) days upon approval;


ENACTED this 15th day of April 2005, Bulalacao, Oriental Mindoro.


