
BE IT ORDAINED by the Sangguniang Bayan of Bulalacao, Oriental Mindoro.




SEC. 2. This Special Ordinance shall take effect immediately.

ENACTED this 3rd day of March, 2008, Bulalacao, Oriental Mindoro.






