
**BE IT ORDAINED** by the Sangguniang Bayan of Bulalacao, Oriental Mindoro:


**SECTION 1.** Section 1 of Ordinance No. 20, series of 1999 entitled " An ordinance regulating speed limitations along Provincial Road, specifically from Foursquare, Campaasan and all municipal streets is hereby amended to read as follows:


**"Section 1. The maximum speed limit for any vehicle travelling the Provincial Road from the front of Barangay Hall of Campaasan and Bulalacao National High School shall be twenty (20) kph."**


**SECTION 2.** This ordinance shall take effect immediately upon its approval.


