ORDINANCE NO. 07-03-073

AN ORDINANCE BANNING THE USE OF COMPRESSOR AS BREATHING APPARATUS IN ALL FISHING ACTIVITIES EXCEPT IN THE OPERATION OF BAKLAD

SPONSOR: Hon. Gabriel C. Hermilao

BE IT ORDAINED by the Sangguniang Bayan of Bulalacao, Oriental Mindoro:

SECTION 1. STATEMENT OF POLICY. Pursuant to Republic Act No. 7160, otherwise known as the Local Government Code of 1991, the Local Government Unit may adopt strategies and policies deemed necessary to ensure the general welfare of the inhabitants against certain practices that might lead to the loss of properties and human lives;

SECTION 2. REGULATED ACTS. In order to avoid the adverse effects of the abovementioned fishing practice, the Sangguniang Bayan of Bulalacao, Oriental Mindoro do hereby banned the use of compressor as breathing apparatus in all fishing activities within the municipal waters of Bulalacao, Oriental Mindoro, except in the operation of "baktad" which is seem to be safe as revealed by the fisherfolks;

SECTION 3. PENALTY.

First Offense - Violation of this Ordinance or parts hereof shall subject the offender to a fine of not more than Php2,500.00 and an imprisonment of not more than six (6) months or both such fine and imprisonment at the discretion of the Court;

Second Offense – 15 days to 1 month impounding of motorbanca, all fishing apparatus and paraphernalia

Third Offense – Confiscation of motorbanca, all fishing apparatus and paraphernalia

SECTION 4. REPEALING CLAUSE. Any Ordinance/s inconsistent with the provision/s of this Ordinance is hereby repealed or modified accordingly.

SECTION 5. EFFECTIVITY. This Ordinance shall take effect immediately.
