ORDINANCE NO. 07-09-74

FURTHER AMENDING AND MODIFYING SECTION 1 OF ORDINANCE NO.
05-01-044 ENTITLED " AN ORDINANCE REGULATING SPEED LIMITATION
ALONG PROVINCIAL ROAD SPECIFICALLY FROM FOURSQUARE
CAMPAASAN AND ALL MUNICIPAL STREETS"

BE IT ORDAINED by the Sangguniang Bayan of Bulalacao, Oriental Mindoro:

SECTION 1. Section 1 of Ordinance No. 05-01-044 entitled "An ordinance regulating speed limitation along Provincial road specifically from Foursquare Campaasan and all municipal streets" is hereby amended to read as follows;

'SECTION 1. The maximum speed limit for any vehicle traversing along the Provincial Road particularly starting from Bulalacao South Junction going to Municipal Parking Area shall be Forty (40) kph and Twenty (20) kph in all municipal streets.'
