**SPECIAL ORDINANCE NO. 10-02-59-A**

SPECIAL ORDINANCE AUTHORIZING THE MUNICIPAL MAYOR TO DONATE TO BARANGAY CAMBUNANG A PARCEL OF LOT CONTAINING AN AREA OF TWO THOUSAND NINE HUNDRED SIXTY EIGHT (2968) SQ.M. TO BE TAKEN FROM THE THREE (3) HECTARES OF LOT OWNED BY THE MUNICIPAL GOVERNMENT OF BULALACAO SITUATED AT THAT BARANGAY TO BE USED AS BARANGAY SITE WHERE BARANGAY OFFICES ARE TO BE ERCTED

BE IT ORDAINED by the Sangguniang Bayan of Bulalacao, Oriental Mindoro:



Villas is hereby authorized to donate to Barangay Cambunang a parcel of lot containing an area of Two Thousand Nine Hundred Sixty Eight (2968) sq.m. to be taken from the three (3) hectares of lot owned by the Municipal Government of Bulalacao situated at that barangay to be used as barangay site where barangay offices are to be erected;



SEC. 2. This Special Ordinance shall take effect immediately.


