OFFICE TO TEMPORARY SUSPEND THE IMPLEMENTATION OF THE
DELINEATION OF THE DIRECT CERTIFICATE OF ANCESTRAL DOMAIN
TITLES (CADT) APPLICATION OF THE MANGYAN HANUNUO ICCS
(STAGE 3) IN THE MUNICIPALITY OF BULALACAO, PROVINCE OF
ORIENTAL MINDORO**

"WHEREAS, the NCIP Oriental Mindoro Provincial Office is currently implementing the continuing project under GAA F.Y. 2022 entitled "Delineation of the Direct CADT Application of the Mangyan Hanunuo ICCs (Stage 3) which covers the Municipalities of Roxas, Mansalay and Bulalacao, Province of Oriental Mindoro;

"WHEREAS, Bulalacao is a third-class Municipality located at the southernmost tip of Oriental Mindoro with a population of 44,366 based on 2020 census, 25 percent of which are indigenous people called Hanunuo Mangyan, it has a municipal government that aims to establish an efficient local organization which is responsive to the needs of the locality and effectively manages its resources to sustain growth and development;

"WHEREAS, the Local Government Unit of Bulalacao vehemently understands the rights of every Hanunuo Mangyan to recognize their ancestral domains and lands that are enclosed in Republic Act 8371, hence, it has the willingness to provide them 30% of the total land area of the municipality;

"WHEREAS, the conduct of perimeter survey of the said Direct CADT Application may affect land areas within territorial jurisdiction of the municipality that the Local Government Unit of Bulalacao is very protective with, for it will be used in introducing sustainable developments in Agro-Eco-Tourism programs, projects, and activities (PPAs) which will be beneficial to all Bulalacaonons;


"WHEREAS, this Sanggunian strongly believes that there should have further studies and consultations before the survey commence for the delineation of this Direct CADT Application to assure which land areas should be included in ancestral domains of the Hanunuo Mangyans and which should remain in the municipal jurisdiction of LGU-Bulalacao; Now, therefore, be it...
