MEMORANDUM OF AGREEMENT

KNOW ALL MEN BY THESE PRESENTS:

This Memorandum of Agreement made and entered into and executed this _____
at _____ by and between:

The **BULALACAO COMMUNITY HOSPITAL (BCH)**, a satellite hospital of the Provincial Government of Oriental Mindoro, with office address at Diversion Road, Campaasan, Bulalacao, Oriental Mindoro, represented herein by **JOSIE ANN L. MARCA, MD, MMHoA** in her capacity as OIC-Chief of Hospital, herein referred to as the "**FIRST PARTY**";

-and-

The **LOCAL GOVERNMENT UNIT OF BULALACAO** a government office existing by virtue of the laws of Republic of the Philippines, with office address at Poblacion, Bulalacao, Oriental Mindoro, represented herein by **HON. LUMELITO M. CABAGAY**, in his capacity as Municipal Mayor, hereinafter referred to as the "**SECOND PARTY**";

-WITNESSETH-

WHEREAS, the **FIRST PARTY** is a public hospital that provides medical services to the people of Bulalacao and, in the course of its operations, produces general (non-hazardous) waste;

WHEREAS, the **SECOND PARTY** through its Municipal Environment and Natural Resources Office (MENRO) or appropriate department, is responsible for solid waste management within the Municipality of Bulalacao, including the collection, hauling, and proper disposal of general waste;

WHEREAS, the **FIRST PARTY** needs collection of general waste to maintain a clean and safe environment for patients, staff, and visitors;

WHEREAS, the **SECOND PARTY** agrees to provide hauling and disposal services for the general waste of the hospital as part of its public service function;

WHEREAS, the **FIRST PARTY** agrees to segregate and prepare the general waste for collection, and the **SECOND PARTY** agrees to collect and dispose of such waste in accordance with local and national environmental laws;

NOW THEREFORE, for and in consideration of the foregoing premises, the parties hereto agree to the following terms and conditions:

GENERAL PROVISIONS

I. OBLIGATIONS OF THE FIRST PARTY

The **FIRST PARTY** shall:

1. Ensure proper segregation of waste at source, in accordance with DOH and DENR guidelines and provide a designated, safe, and secure storage area for collected hospital waste prior to collection by the **SECOND PARTY** or an authorized service provider.
2. Waste shall be properly labeled, packaged, and stored in accordance with DOH

II. OBLIGATIONS OF THE SECOND PARTY

The SECOND PARTY shall:

1. Facilitate the regular collection of general (non-hazardous and non-infectious) hospital waste from the FIRST PARTY's facility.
2. Ensure the safe transport and proper disposal of collected waste in an authorized and sanitary disposal facility.
3. Provide technical assistance and monitoring to ensure the FIRST PARTY's compliance with waste management standards.
4. Assist in conducting Information, Education, and Communication (IEC) campaigns on proper waste segregation and disposal practices for hospital personnel and nearby communities.

DURATION

This Agreement has lock-in period from September 12, 2025 until December 31, 2025. An extension hereof shall be subjected to another negotiation between the contracting parties.

EFFECTIVITY

This Memorandum of Agreement shall be in full force and takes effect on the day it is signed by the parties and shall be in full force and effect until terminated or unless a new Agreement shall have been entered.


