RESOLUTION NO. 17

RESOLUTION IN THE MATTER OF DISPENSING WITH AND/OR THROUGH SIX SUBSIDIZED
THE SALARY OF MR. DOMENICO S. LAQUINDAY, AN ACTUALLY MUNICIPAL TREASURER
OF MALABAGO, ORIENTAL MINDORO AT THE RATE OF P2,100.00 PER ANNUM AND TO
PAY ONLY THE SALARY OF BOOKKEEPER AT MALABAGO, ORIENTAL MINDORO AT THE
RATE OF P1,650.00:

WHEREAS, that Mr. DOMENICO S. LAQUINDAY appointed Assistant Muni-
cipal Treasurer of Malabago, Oriental Mindoro does not possess civil
service eligibility as per last determination made by the Civil Service
Commission dated January 10, 1970 and returned disapproved; and

WHEREAS, that the appointments made on September 10, 1969, have
not met the requirements and he is not to be eligible for the position
as called forth, under Article No. 230; Sec. 20; C.S. Rule No. IV;
Sec. 8; Gen. Ord. No. 2 and order of 1966; and

WHEREAS, that he took civil service examination at Calapan,
Oriental Mindoro dated July 15, 1966, by complete records as to his
rating obtained, been given to this body and certified to, by the Co-
mmissioner of Civil Service and other competent authorities, that he
possessed and passed the civil service examination as Provincial Clerk
in the category of Assistant Municipal Treasurer; and

WHEREAS, of the facts, that during his incumbency as bookkeeper at
Malabago, Oriental Mindoro, in the office of the Municipal Treasurer, he is
dealing only with a compensation at the rate of P1,650.00 per annum
which is equivalent to the rate of civil service eligible; and

On motion of Mr. Jessie Gato, Municipal Councilor and duly seconded
by Mr. Leovigildo Soliano, Municipal Councilor.

It is, THEREFORE, resolved as it is hereby resolved, that the Assistant
Municipal Treasurer, Mr. DOMENICO S. LAQUINDAY of Malabago, Oriental
Mindoro if he cannot reproduce or show his rating obtained during civil
service examination taken at Calapan, Oriental Mindoro as Provincial
Clerk or in other category for the position mentioned, this body, the

Municipal Council of Bulacan, Oriental Mindoro intervened to object to disburse with and/or temporarily suspended his salary as Assistant Municipal Treasurer at the rate of P2,200.00 per annum and to receive only his salary at the amount of P1,600.00 per annum as Treasurer's salary at Manila, Oriental Mindoro due to his ineligibility for the position as Assistant Municipal Treasurer; and

RESOLVED FURTHER: that if Mr. DOMENEC S. LIGTERKY can reproduce his salary obtained given by the Civil Service Commission in the capacity as Provincial Clerk and/or Assistant Municipal Treasurer, this body, the Municipal Council of Bulacan shall restore his salary, commencing from the date of the certification of the Civil Service Commission and/or other competent institution certifying his eligibility for the above-mentioned position; and



LIGTERKY, Bulacan, Oriental Mindoro for their file and reference.
