RESOLUTION NO. 24

RESOLUTION IN THE MATTER OF APPROVING TEMPORARILY THE ERECTION OF PRE-FABRICATED SCHOOL BUILDING (HARCOS TYPE) AT POBLACION ADJACENT TO THE OLD DISPENSARY BUILDING UNTIL AVAILABLE SITE OR LOT FOR IT, BE SECURED:

WHEREAS, the municipal mayor of Bulalacao, Oriental Mindoro, presented a resolution before the Municipal Council of Bulalacao, that pre-fabricated school building (Harcos Type) be temporary erected and built at poblacion adjacent to the old dispensary building until a site or lot for final erection be found and secured; and

REALIZING, that the erection of said Pre-Fabricated school building is beneficial to all high school students, ~~inasmuch as~~ being major ages, whose conducts and behavior are unpolished and unrefined, that their acts can be easily check-up by any peace officer who ever dares to commit any prejudicial act or acts to a person or persons; and

CONSIDERING, that the temporary erection in poblacion of said pre-fabricated school building usable by high school students is not beneficial to the progress of the plaza, this body, the Municipal Council of Bulalacao deem it best and proper to erect the Pre-Fabricated school building temporarily adjacent to the old dispensary building for the mean time until a lot or site be allocated and secured; and


On motion of councilor Ulpiano C. Rindino and duly seconded by Councilor Juan P. Tomplaza,

NOW, THEREFORE, resolved as it is hereby resolved, by this body, the Municipal Council of Bulalacao, Oriental Mindoro, that the temporary erection of the Pre-fabricated school building adjacent to the old dispensary building be approved and to be transferred later as soon as site or lot be allocated and secured.
