GRANTING FREE SCHOLARSHIPS TO GRADE VI VALEDICTORIANS AND FIRST HONORS STUDENTS IN THE MUNICIPAL HIGH SCHOOL OF BULALACAO, ORIENTAL MINDORO.

WHEREAS, there are Grade VI Valedictorians in this Municipality as well as there are First honors Students from First year up to Fourth year in the Municipal High School of Bulalacao, Oriental Mindoro;

WHEREAS, in order to encourage, the Primary, and the Elementary pupils as well as the Municipal High school students to study harder, free scholarship will be granted to valedictorian and First Honors in the Bulalacao Municipal High School beginning this school year 1981;

WHEREAS, scholars shall be entitled only to the tuition fees prescribed thereat. He shall pay school contribution and other fees relative to student activities;

WHEREAS, in the event there are First Honor students in each section of the same year in the Municipal High School, the First Honors student who has the highest ratings of them all, shall be granted the scholarship;

WHEREAS, free scholarship shall be granted and extended only to students who maintain the highest ratings at the end of the school year;

NOW, THEREFORE, resolved as it is hereby resolved to grant free scholarships to Grade VI Valedictorians and First Honors Student in the Municipal High School of Bulalacao, Oriental Mindoro beginning this school year 1981.
