AMENDING RESOLUTION NO. 31 OF THE SANGGUNILANG BAYAN OF BULALACAO, ORIENTAL MINDORO, DATED JULY 2, 1986

WHEREAS, Resolution No. 31, dated July 2, 1986 to sell to ORMECO II one hectare out of less than three hectares, owned by the Municipal government at Sitio Maradanum this municipality for the construction of electric plant is hereby amended on the following grounds:

- a) That as per evaluation and recommendation of expenses by the ORMECO Engineer, the construction of electric plant in the government site is too expensive so that ORMECO II decided to exchange said lot with the lot of Mrs. Nympha Tolentino, also located at Sitio Mardanum, this municipality;
- b) That Mrs. Nympha Tolentino with the desire to help the immediate electrification of the municipality hereby agreed to exchange Her one hectare in lieu of the one hectare property of the Municipal Government;
- c) That upon exerting our effort to look for other plant site along the recommended area, no private person agreed to sell one hectare for the ample price of ₱10,000.00 only;

NOW, THEREFORE, resolved as it is hereby resolved to amend Resolution No. 31, dated July 2, 1986 and exchanging the Municipal government lot of one hectare with the lot of Mrs. Nympha Tolentino, located at Sitio Maradanum for the construction of electric plant of ORMECO II;

RESOLVED, FURTHER, that copies of this resolution be furnished, the Manager, ORMECO II, Pinamaleyan, Oriental Mindoro and Mrs. Nympha Tolentino, Poblacion, this municipality for their information, guidance and reference;
