“WHEREAS, todays global guiding principles and ethical communication procedures are now done through intelligent machines, such as computers;


“WHEREAS, sadly this Office is still wanting of sufficient units of computer to cope up with the demands of the work common in every sanggunian; Now, therefore, be it


