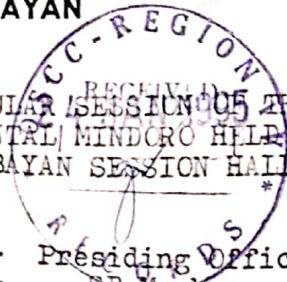

" RESOLUTION NO. 95-01-01

EARNESTLY REQUESTING REGIONAL DIRECTOR JOSE S. DAPNOZA, OFFICE FOR SOUTHERN CULTURAL COMMUNITIES TO DEFER THE TRANSFER OF ITS DISTRICT OFFICE FROM THE MUNICIPALITY OF BULALACAO TO BONGABONG ORIENTAL MINDORO

"WHEREAS, the creation of the Office for Southern Cultural Communities and the subsequent establishment of one of its offices at Dangkalan, this Municipality, have made essential contributions to the improvement of the quality of life of the Hanunuo Mangyans;

"WHEREAS, Hanunuo Mangyans account to no less than twenty-five percent (25%) of the total population of Bulalacao, Oriental Mindoro;

"WHEREAS, among the noteworthy contributions extended by OSCC to the lot of our tribal brothers, Hanunuo Mangyans, are seen in terms of agricultural support services, animal dispersal, medical assistance and social education;

"WHEREAS, it is unfortunate that we hear of OSCC's transfer from this municipality to Bongabong, Oriental Mindoro as the magnitude of effects of this untimely pull out will cause confusion, disintegration and abortion of the already started laudable projects;

"WHEREAS, this body is firm on its belief that the Office of OSCC should remain on this place in order to dispel any untoward effects on the life of our brother Hanunuo Mangyans by the sudden withdrawal of the personnels of OSCC with whom members of this indigenous tribal group have developed a strong camaraderie, harmonious working relationship and mutual trust;

"WHEREAS, it is with deep sincerity that this sanggunian feels the need by the Hanunuo Mangyans for a partner in the person of OSCC as they stand for the preservation of their cultural identity, battle against poverty and the abuses/exploitation committed against their honor, life, and property by some unscrupulous individuals, Now therefore, be it;


RESOLVED by the Sangguniang Bayan, That it earnestly request as it hereby requests Regional Director Jose S. Dapnoza, Office for Southern Cultural Communities to defer the transfer of its district office from this Municipality to Bongabong, Oriental Mindoro;


