### RESOLUTION NO. 11-05-086

EARNESTLY REQUESTING HONORABLE REYNALDO V. UMALI, CONGRESSMAN, SECOND DISTRICT, PROVINCE OF ORIENTAL MINDORO TO ALLOCATE FUNDS FOR THE CONSTRUCTION OF DPWH-DEPED STANDARD SCHOOL BUILDING WITH TWO (2) CLASSROOMS AT BNHS MAIN, BARANGAY CAMPAASAN, BULALACAO, ORIENTAL MINDORO, A PRIORITY PROJECT OF THE PCL-OMF AND THE SANGGUNIANG BAYAN OF BULALACAO
