RESOLUTION NO. 11-05-083

REQUESTING THE HONORABLE GEORGE ARNAIZ, CHAIRMAN, COMMITTEE ON LOCAL GOVERNMENT, HOUSE OF REPRESENTATIVES, DILIMAN, QUEZON CITY, TO SPONSOR A BILL AMENDING SECTION 17 (2ii), CHAPTER II OF REPUBLIC ACT NO. 7160 OTHERWISE KNOWN AS THE LOCAL GOVERNMENT CODE OF 1991 BY GRANTING ALL MUNICIPALITIES FULL DEVOLUTION TO IMPLEMENT COMMUNITY-BASED FORESTRY PROGRAMS AND OTHER SIMILAR PROJECTS

"WHEREAS, the Local Government Code of 1991 in spite of the promising provisions, actions by municipalities on environment and natural resource management are still subject to the supervision, control and review of the Department of Environment and Natural Resources (DENR) because of limited devolution;

"WHEREAS, the municipalities sought to acquire more powers and resources from the national government so that it could take more proactive lead role in environment programs;

"WHEREAS, full devolution of environmental powers to municipalities are stressed which will necessitate amendments to the Local Government Code of 1991,

"WHEREAS, if the environment is properly managed it will help maintain ecological balance, minimize the occurrence of floods and droughts and could mitigate the effects of adverse climatic changes;

"WHEREAS, local efforts were hampered because of the limited powers of the municipalities; Now, therefore, be it


RESOLVED AS IT IS HEREBY RESOLVED, To: Request the Honorable George Amaz, Chairman, Committee on Local Government, House of Representatives, Diliman, Quezon City to sponsor a Bill Amending Section 17 (20), Chapter II of Republic Act No. 7160 otherwise known as the Local Government Code of 1991 by granting all municipalities full devolution to implement community-based forestry programs and other similar projects.

RESOLVED FURTHER, That copy of this resolution be furnished the Honorable Jesse M. Robledo, Secretary, Department of Interior and Local Government, Diliman, Quezon City, for his information and favorable consideration.




